Law And Practice Of Commissions

The Nebraska Supreme Court (Court) exercises jurisdiction over admission to the practice of law in the State of Nebraska. The Court established the Nebraska State Bar Commission (Commission) to review all applicants and make recommendations to the Court for admission.

1 The Law Commission. E+W+S+N.I. (1) For the purpose of promoting the reform of the law [F1 of England and Wales] there shall be constituted in accordance with this section a body of Commissioners, to be known as the Law Commission, consisting [F2 (except during any temporary vacancy)] of a Chairman and four other Commissioners appointed by the Lord Chancellor.
